PGO is the premier and largest nationwide geography quiz bee competition for junior and senior high school students. The Olympiad has been an excellent venue for students to showcase their knowledge and understanding in the field of geography through a series of friendly scholastic competitions. It is recognized by the International Geographical Union (IGU) as the country's official national geography competition. The winners of the Olympiad become the official delegates to the annual International Geography Olympiad (iGeo).
