The Department of Education (DepED) Cebu City Division, through the FY 2020 General Appropriation Act (GAA), intends to apply the sum of One Million One Hundred Ninety Five Thousand Two Hundred Thirty Four Pesos and One Centavo (Php 1,195,234.01), being the Approved Budget for the Contract (ABC), to eligible payments under the contract for the (RE-BIDDING) CY 2020 BASIC EDUCATIONAL FACILITIES FUND (BEFF) - REPAIR OF CLASSROOMS at LUSARAN NHS under the DepEd FY 2020 GAA. Bids received that exceed the ABC per Project Code No. shall be rejected at bid opening.

- The DepEd Cebu City Division of Region VII now invites bids for the above mentioned works. Bidders should have completed a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.
- 3. Bidding will be conducted through open competitive bidding procedures using nondiscretionary "pass/fail" criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act 9184 (RA 9184), otherwise known as the "Government Procurement Reform Act."
 - Bidding is restricted to Filipino citizens/sole proprietorships, cooperatives, and partnerships or organizations with at least seventy five percent (75%) interest or outstanding capital stock belonging to citizens of the Philippines.
- Interested bidders may obtain further information from DepEd Cebu City Division and inspect the Bidding Documents at the address given below during Mondays to Fridays from September 17, 2020 – October 7, 2020.
- 5. A complete set of Bidding Documents may be acquired by interested bidders on September 17, 2020 to October 7, 2020 from Mondays to Fridays from the address below and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of Five Thousand Pesos (Php 5,000.00):

It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the Procuring Entity, provided that bidders shall pay the applicable fee for the Bidding Documents not later than the submission of their bids.

- 6. The DepEd Cebu City Division of Region VII will hold a Pre-Bid Conference on September 25, 2020 at 11:00 am PhST at Zapatera Library, Gabaldon Building, Zapatera Elementary School, Sikatuna St. Cebu City, which shall be opened to prospective bidders.
- 7. Bids must be duly received by the BAC Secretariat on or before October 7, 2020 at 11:00 am PhST at Zapatera Library, Gabaldon Building, Zapatera Elementary School, Sikatuna St. Cebu City. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 18.
- 8. Bid opening shall be October 7, 2020 at 11:00 am PhST at Zapatera *Library*, *Gabaldon Building*, *Zapatera Elementary School*, *Sikatuna St. Cebu City*. Bids will be opened in the presence of the bidders' representatives who choose to attend at the address below. Late bids shall not be accepted.

The Bidding Documents may be viewed also at the DepEd Official Website, www.deped.gov.ph.
