## INVITATION TO BID FOR SUPPLY AND DELIVERY OF HEALTH KIT FOR DEPED CEBU CITY DIVISION

The DepEd Cebu City Division, through the FY 2022 General Appropriation Act (GAA) intends to apply the sum of Four Million Three Hundred Thirty-Five Thousand Seven Hundred Fifty Pesos (Php 4,335,750.00) being the ABC to payments under the contract for Supply and Delivery of Health Kit for DepEd Cebu City Division. Bids received in excess of the ABC shall be automatically rejected at bid opening.

- 2. The DepEd Cebu City Division now invites bids for the above Procurement Project. Delivery of the Goods required as stated in Section VI. Schedule of Requirements. Bidders should have completed, within five (5) years from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).
- Bid ding will be conducted through open competitive bidding procedures using a nondiscretionary "pass/fail" criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.
  - a. Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA No. 5183.
- Prospective Bidders may obtain further information from DepEd Cebu City Division and inspect the Bidding Documents at the address given below during Mondays to Fridays from 8:00 am - 5:00 pm from October 6, 2022 to October 26, 2022.

- 5. A complete set of Bidding Documents may be acquired by interested Bidders on October 6, 2022 to October 26, 2022 from Mondays to Fridays from the given address and website(s) below and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of Five Hundred Pesos (Php 500.00) for Lot 1 and Five Thousand Pesos (Php 5,000.00) for Lot 2. The Procuring Entity shall allow the bidder to present its proof of payment for the fees presented in person.
- 6. The DepEd Cebu City Division will hold a Pre-Bid Conference<sup>1</sup> on October 14, 2022 at 10:00 am PhST at Zapatera Library, Gabaldon Building, Zapatera Elementary School, Sikatuna St. Cebu City, which shall be open to prospective bidders.
- 7. Bids must be duly received by the BAC Secretariat through manual submission at the office address indicated below, on or before October 26, 2022 at 10:00 am PhST. Late bids shall not be accepted.
- 8. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 14.
- Bid opening shall be on October 26, 2022 at 10:00 am PhST at Zapatera Library, Gabaldon Building, Zapatera Elementary School, Sikatuna St. Cebu City. Bids will be opened in the presence of the bidders' representatives who choose to attend the activity.
